The quality of nominations is the most important consideration for the shortlisting panel.

Biographical data

Please list some pertinent biographical data (for individuals and organisations where applicable) or attach resume.

Qualifications

Please include a concise statement of the qualifications of the nominee.

Achievements

Please make a summary of his/her/its main contributions to hydro-environment engineering and science. The following are the merits to take into consideration:

- a. **Publications.** List and number of books or monographs (as main author or chapter contributor), list and number of peer-reviewed papers (journals and conferences), list and number of technical reports, other publications (magazines, etc.).
- b. **Recognitions.** Awards, recognitions, and biographical citations.
- c. **Visiting positions and invited speeches.**
- d. **Research outreach.** Seminars, educational programmes, presentations, etc.
- e. **Service to IAHR.** Leadership positions, reviewer or editor of IAHR journals, organisation of conferences/symposiums, etc.
- f. **Impact.** Contributions of seminal importance in research, extraordinary contributions to academic programmes, etc.

Statement

Remember that general statements tend to lack the detail needed for shortlisting. Ideally, aim to reference the specific impact the nominee has had with respect to the selection criteria.
